Explore the investigation and restoration of the atrium and upper walkways at The Residences at Pier 5, a historic condominium complex located within a 1923 cargo pier along the Delaware River in Philadelphia. This case study examines waterproofing failures, concealed structural deterioration, and corrosion of steel framing, along with the evolving repair strategies and construction challenges encountered throughout the project. Attendees will gain valuable insight into managing scope changes, budget constraints, and long-term durability considerations in complex waterfront rehabilitation projects.
